Applied Strategic Planning: presented by Shirley Holt-Hale

Progress Report: The Applied Strategic Planning committee met June 2009 to discuss and evaluate the current ASP document.

Anticipated Plans: This document will be placed on the web for members to process and review.

Health Professional of the Year Andrea Cain Connie Hall Givens CSH Award Mesina Bullock

Cam Kerst-Davis is concerned that the criteria for the award nominations are not appropriate since a person may be nominated only once and receive the award. Shirley

Holt Hale suggests doing the voting of the awards electronically so that it is anonymous. J.P. Barfield identified that the Elementary TOY award is the one under consideration. Tina Bozeman asks that the awards with exception of the Elementary TOY be moved, while the ETOY goes back to the Awards committee for further consideration. Carol Irwin wonders if the amount of work necessary (in a short time frame) to receive an award is too much; therefore applicants fail to meet the requirements.

Tracey McClain made a motion to approve all awards with the exception of the Elementary TOY until further discussion on applicant. Tracey McClain made the 1st motion, Cam Kerst-Davis 2nd.

Katherine Pebworth motioned that the President create a committee to look at the awards criteria rating/ranking system. There needs to be a minimum score in order to qualify the award. In the future all awards use the new system. Katherine Pebworth made the 1st motion, Carol Krueckeberg 2nd.

J.P. Barfield read an email from Anna Rose Davis about the nomination of Peggy Evans Thomas for the NAGWS Pathfinder Award. Tina Bozeman remarks that there is a deadline for award nominations and that we should not fall back at this time.

Constitution: Presented by Tina Bozeman

Progress Report: Members of the Constitution Committee were surveyed by e-mail to determine if any items regarding the *Constitution and Bylaws* needed to be brought to the Board for consideration at the fall meeting. No items were identified for consideration at this time.

Anticipated Plans: The Committee will continue to review the Constitution and Bylaws to identify any needed changes.

Action Required by the Board: An amendment to the Bylaws to allow all board members (both Executive Board and TAHPERD Board) to vote at Board Meetings was passed at the September 2008 Fall Board meeting. This amendment was inadvertently omitted from the list of amendments which was presented to the membership for approval at the November 2008 Convention General Session. The previous and revised wording is as follows:

Article III. TAHPERD Board

Section 2.

Previous wording:

Members of the TAHPERD Board are encouraged to attend any and all Executive Board meetings, without vote, and may be requested to attend specific Executive Board meetings.

Revised wording:

Members of the TAHPERD Board are encouraged to attend any and all Executive Board meetings with full participation and full voting rights and may be requested to attend specific Executive Board meetings.

Rationale:

Motion made at the September 2008 board meeting to allow all board members voting rights.

Required Action: The revised wording to Bylaws Article III. Section 2. must be presented to the membership for approval. The vote may be taken either by mail, e-mail, or at a Convention General Session.

Budget Implications: None

Finance: Presented by J.P. Barfield

Due to the reduction in JRH funds in an amount of \$7,136.87 from the anticipated \$47,000, action is needed to cover the shortfall in the budget.

J.P. motions to reduce JRFH special projects expense line by \$700 and increase the Money Market income line by \$7,136.87 in 2009-2010 budget. Christi Hoffman seconds this motion.

Budget Implications: Action will be a solution this year. Future budget requests should reflect the anticipated reduction in JRH funds.

Membership: Presented by Susan Kirkpatrick

Progress Report: The membership committee has been brainstorming over new ways to get the word out to people we have not reached in schools that we don't have contact with yet. Also, Dr. Jordan, TTU, and I have been talking about ways to get universities involved in our association and finding an effective line of communication for that.

Liz Holbrook and Mary Lou Veal have worked to grow research poster and round table sessions.

Kathy Caudill and J. P. Barfield are working on registration, membership and promotion of convention—trying to get the most from our new technology capabilities.

Exhibits: Presented by John Parks

Progress Report: We are excited about all the exhibitors that have signed on so far. We have Gopher, Skatetime, Tennessee Bowling Assoc., Speedstacks and EPEC (Michigan Fitness) all signed up with the Platinum booth space which gives them a corner space. The exhibitors who selected our Gold booth space are MTSU, Gandy Ink Spiritwear, Blue Cross Walking Works for Schools, The Spark Programs, The Spirited Athlete, and Human Kinetics. The Silver exhibitors are Image Sport, USTA, American Heart Association. Flaghouse is submitting their paperwork soon. I have received word from HealthTeacher, Gametime, and Vanderbilt Orthopaedic Institute that they will not be able to join us this year. I am still waiting for Polar USA, GoTrybe and other universities to contact me. I hope they will respond soon.

Demonstration Schools: Shirley Holt-Hale

The Demonstration School Committee met Thursday, June 11th at Tennessee Tech University. The agenda for the meeting focused on the promotion of the Demonstration School Project and the revision of the secondary school criteria.

Promotion of the Project:

- 1. The criteria for elementary and middle/junior high will be posted on the TAHPERD website. Existing secondary school criteria will be posted with a caveat regarding revision.
- 2. The Demonstration School Committee will host a booth at the exhibits during TAHPERD convention. The Demo School flag will serve as backdrop (Kathy). Brochures from NASPE regarding quality physical education will be available

(Shirley). Photos and displays of quality physical education/why be a demonstration school will be included in the booth. Both present and past demonstration school personnel will be asked to "man" the booth to answer questions and invite conversation from visitors.

3. Middle and secondary schools that had expressed interest in the Demonstration School project were contacted in late August to follow-up interest.

Revision of Secondary School Criteria (Summary of Discussion):

The 2009-10 school year will be used to identify quality programs of secondary physical education/wellness and solicit input regarding programs. The Committee, plus special guests, will meet during the summer of 2010 to revise the secondary criteria to reflect the wellness mandate and requirements from the State Board and State Department of Education.

Resource Schools:

The Committee discussed a possible listing of resource schools with quality programs in particular areas of physical education, schools that might not apply for or meet the criteria for Demonstration Schools, e.g., schools strong in dance, gymnastics, fitness, etc. These schools would be listed as Resource Schools with the Demonstration School information posted on the TAHPERD website. They would not have demonstration days, but would be available for contact to arrange visitation.

Action: None at this time. Further discussion and decision at Convention Meeting of Committee.

Health and Wellness: Presented by Bev Corlew

Old Business

National Physical Activity participation: J.P. Barfield

Cam-Kerst Davis and Anna Rose Anderson attended the 2009 Summer Conference on the Physical Activity Guidelines for Americans. J.P. Barfield indicated the guidelines called for 60 minutes of daily physical activity of children and 150 minutes of moderate or 75 minutes of vigorous activity for adults.

Shirley Holt-Hale believes that at any time we provide funds for our members to go to conventions or workshops there should be a follow-up whether it is in the newsletter, on the website, or otherwise.

SPARK training: J.P. Barfield

A dead issue due to the cost. There is no interest.

Southern District Leadership Conference: Lisa Lewis, EJ Wood, J.P. Barfield, and Cam Kerst-Davis represented TAHPERD at the Summer Leadership Conference in

Myrtle Beach. Attendees learned about TAHPERD's role in Southern District and participated in various leadership development sessions.

Guidelines for administering the mile walk/run assessment for Coordinated School Health: Tina Bozeman

There are many issues that the President's task force has been unable to confer with each other about. For instance the ½ mile is more appropriate for the kindergarten age group. Tina Bozeman has asked for Lee Allsbrook to serve on the committee, Lee confirmed this position.

Lee Allsbrook has offered to utilize Skype as an electronic way of seeing board members.

New Business

Tennessee School Health Coalition: Elaine Jackson presented flyers about TN School Health Coalition and recruited perspective members to join.

There is a vacant spot on the TAHPERD board for a Coordinated School Health person.

Waiver/discount for student workers at 2009 convention: Mary Lou Veal The proposal is for student workers to serve at 3 sessions, be a member of TAHPERD, and therefore receive free TAHPERD convention dues. With MTSU students as the volunteers we would also help to meet their needs of going to their classes.

J.P. Barfield is concerned that these students may not fulfill their obligation, but still receive a free convention fee. There is also a registration table in which student workers reside.

Tina Bozeman believes that it is the university supervisor's responsibility to document those students who work and if they met the obligations.

After a few minutes of debate these thoughts came up: presenters have to pay to attend the convention; students should not get a waived fee, it is a learning process to compensate for your time; students already get a discounted fee compared to everyone else; could there be other items that can be done for student workers in appreciation of their hard work (t-shirts, food, etc.); faculty donations for students to attend Mary Lou Veal made the 1st motion for students who serve, Marcy Maurer 2nd.

<u>Motion 7</u>: Motion to accept the revised 09-10 budget following JRFH changes (see motion #3).

Vote: Passed Unanimously

Bev Corlew talked about her experiences at the Washington, D.C. conference.

J.P. Barfield addressed the Fit Kids Act as well as the number of TAHPERD members and convention attendees.

Shirley Holt-Hale addressed Congressman Zac Wamp as being a supporter of physical education. Tina Bozeman informed the board that he will be speaking at a luncheon.

President Bozeman thanked the board for caring about the association, for suggestions, and feedback.

Bev Corlew made a motion to adjourn the meeting.
